ORDER
Petitioner's Motion for Admission *Pro Hac Vice*
of Mark A. Chapman
37 C.F.R. § 42.10

As authorized by the Notice of Filing Date Accorded to Petition (Paper 3), Petitioner Toyota Motor Corporation filed a Motion for *Pro Hac Vice* Admission of Mark A. Chapman. Paper 5.¹ Patent Owner Signal IP, Inc., did not file an opposition to the Motion. Petitioner's Motion is *granted*. See 37 C.F.R. § 42.10(c); see also *Unified Patents, Inc. v. It is

ORDERED that Petitioner's Motion for *pro hac vice* admission is *granted*, and Mr. Chapman is authorized to represent Petitioner as back-up counsel in IPR2016-01382.

FURTHER ORDERED that Petitioner is to continue to have a registered practitioner as lead counsel in this *inter partes* review proceeding; and

FURTHER ORDERED that Mr. Chapman is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Title 37, Part 42 of the Code of Federal Regulations, and that Mr. Chapman is subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et seq.*
