ORDER Withdrawal of Counsel 37 C.F.R. § 42.10



Pursuant to our authorization, Petitioner filed a Motion to Withdraw Counsel and Substitute New Counsel. Paper 15. Petitioner indicates that Patent Owner does not oppose the motion and no opposition has been filed. Petitioner requests that we authorize the withdrawal of P. FURTHER ORDERED that Mr. Lionel M. Lavenue will be recognized as lead counsel for Petitioner, effective the date of this decision.
