On May 1, 2017, the parties filed in each of the above-captioned cases a joint motion to terminate the respective *inter partes* review. Paper 12. Also on May 1, 2017, the parties filed in each of these cases a copy of their written settlement agreement and a request to treat the settlement agreement as business confidential information. Paper 13; Ex. 2001.

Under 35 U.S.C. § 317(a):

An inter partes review instituted under this chapter shall be terminated with respect to any petitioner upon the joint request of the petitioner and patent owner, unless the Office has decided the merits of the proceeding before the request for termination is filed. . . . . If no petitioner remains in the inter partes review, the Office may terminate the review or proceed to a final written decision under section 318(a).

The requirements for terminating these proceedings with respect to both parties are met.

It is hereby:

ORDERED that the joint motions of Petitioner and Patent Owner to terminate proceedings are *granted*;

FURTHER ORDERED that the *inter partes* review instituted for IPR2016-01811 is terminated;

FURTHER ORDERED that the *inter partes* review instituted for IPR2016-01813 is terminated; and

FURTHER ORDERED that the joint requests of Petitioner and Patent Owner to have their settlement agreement (Exhibit 2001) treated as business confidential information under 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74(c) are *granted*.
