ORDER

Pro Hac Vice Admission of Stephen M. Ullmer
37 C.F.R. § 42.10(c)

As authorized in the Notice of Filing Date Accorded to Petition (Paper 3), Petitioner, Limelight Networks, Inc., moves for admission *pro hac vice* of Mr. Stephen M. Ullmer (Paper 14, “Motion”). Petitioner also filed an Affidavit of Stephen M. Ullmer in Support of the Motion for *Pro Hac Vice* Admission. Ex. 1017. The Motion does not state whether it is unopposed, but Patent Owner, Akamai Technologies, Inc., filed no opposition. The Motion is *granted*. See 37 C.F.R. § 42.10(c); *see also* IPR2013-00639, Paper 7 (setting forth requirements for *pro hac vice* admission).¹

It is

ORDERED that the Motion seeking admission *pro hac vice* for Stephen M. Ullmer is granted;

FURTHER ORDERED that Stephen M. Ullmer is authorized to represent Petitioner as backup counsel in this proceeding;

FURTHER ORDERED that a registered practitioner must remain as lead counsel throughout the proceeding;

FURTHER ORDERED that Stephen M. Ullmer is to comply with the Office Patent Trial Practice Guide and the Board’s Rules of Practice for Trials, as set forth in Part 42 of the C.F.R.; and

FURTHER ORDERED that Stephen M. Ullmer is to be subject to the Office’s disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et. seq.*
