Counsel: The Federal Circuit vacated the Board's final written decision in this case and remanded to the Board for proceedings consistent with *Arthrex, Inc. v. Smith & Nephew, Inc.*, 941 F.3d 1320 (Fed. Cir. 2019). *Uniloc 2017 LLC v. Cisco Sys., Inc.*, No. 18-2431, Dkt. No. 44 (Jan. 23, 2020). On May 1, 2020, a General Order was entered in this case, holding the case in abeyance. Paper 22. That abeyance was lifted on October 26, 2021. Paper 23. The parties shall meet and confer in a reasonable and good faith attempt to propose a procedure on remand. See PTAB Standard Operating Procedure 9, Appendix 2. Within ten business days of this email, the parties shall jointly file a Proposed Procedure on Remand.
