PETITIONER'S REQUEST FOR ORAL HEARING

1. Request to Consolidate Cases for Oral Hearing

Because of overlapping subject matter and issues in both cases, and to expedite the proceedings, Petitioner respectfully requests a *single* consolidated oral hearing, with each side having **30 minutes** to present.

2. Issues to be Presented During Oral Hearing

During the oral hearing, Petitioner requests the opportunity to present oral argument on all of the issues raised in the papers pertaining to the instituted grounds, including:

 Hamberg and Lamb render obvious "generating a conference call request responsive to a single request by the conference call requester," through Lamb's CALL and CONF.NOW buttons and Hamberg's CALL ALIAS message.



- Hamberg and Lamb render obvious "automatically establishing a conference call connection to ... each of the potential targets," through Hamberg's description of establishing a conference call with group members who are logged into a server and participating in an instant messaging session.
- Hamberg and Lamb render obvious "presenting to said conference call requester a display showing a plurality of potential targets" through Lamb's display of status information that can be provided on Hamberg's mobile stations.
