On January 12, 2018, we granted Petitioner's request for oral hearing for these proceedings. Paper 19.<sup>2</sup> By email request, Petitioner withdraws its request for a hearing and asks that we cancel the hearing scheduled for February 7, 2018. Ex. 3001.

As noted in Petitioner's request, Patent Owner did not request a hearing for these proceedings. *See id.* Petitioner asserts that after further consideration and in an effort to preserve party and Board resources, it agrees with Patent Owner that a hearing is not necessary. *Id.* Petitioner represents that it discussed its request with Patent Owner's lead counsel so that there would be no wasted effort on Patent Owner's part with respect to hearing preparation. *Id.* Under the circumstances, we determine it is appropriate to grant Petitioner's request to cancel the consolidated oral hearing for these proceedings.
