#### **REQUEST FOR REFUND OF POST-INSTITUTION FEES**

On November 3, 2016, Petitioner filed a Petition for *Inter Partes* Review of U.S. Patent No. 9,179,019 (Paper 2) requesting review of fifty-six (56) claims. Petitioner paid a fee of \$46,600, including: (i) \$9,000 for an *inter partes* review request fee for up to twenty (20) claims; (ii) \$7,200 for an *inter partes* review request of each claim in excess of twenty (20) claims; (iii) \$14,000 for an *inter partes* review post-institution fee up to fifteen (15) claims; and (iv) \$16,400 for an inter partes review post-institution fee for each claim in excess of fifteen (15) claims. On April 25, 2017, the Board instituted *Inter Partes* Review (Paper 6), but only as to twenty-one (21) claims. Petitioner therefore requests a refund of \$14,000 of the *inter partes* review post-institution fee under (iv) above for the thirty-five (35) remaining claims where trial was not instituted.
