Petitioner Argentum Pharmaceuticals ("Argentum") requests authorization to file a Sur-Reply to the Reply by Kaken Pharmaceutical Co., Ltd. and Valeant Pharmaceuticals International, Inc. ("Patent Owner") in support of its joint motion with Petitioner Acrux DDS PTY Ltd. and Acrux Limited ("Acrux") to terminate this proceeding. *See* Ex. 3003, 1. Specifically, Argentum asserts that good cause exists for its extension because it seeks to respond to Patent Owner's statements concerning Argentum's role and actions in this proceeding by providing the panel complete information. *Id.* Argentum requests one week to file its Sur-Reply. *Id.*
