U.S. Patent Nos. 7,590,602, 8,051,011, and 8,195,578 (the "Related Moneycat Patents") were the subject of covered business method review in CBM2014-00091, CBM2014-00092, CBM2014-00093, and CBM2015-00008. Moneycat appealed the Board's decisions in CBM2014-00091, -00092, and -00093 to the Court of Appeals for the Federal Circuit as Case Nos. 2016-1399, 2016-1405, and 2016-1408. On February 24, 2017, the Court of Appeals for the Federal Circuit issued its mandate affirming the Board's determinations that claims 1, 2, and 4-11 of the '602 patent, claims 1, 2, 4-8, 10, and 11 of the '011 patent, and claims 1-3, 5-11, and 13-23 of the '578 patent are unpatentable as obvious under 35 U.S.C. § 103.
