**REQUEST FOR REFUND OF POST-INSTITUTION FEES**

On January 12, 2017, Petitioner Westinghouse Air Brake Technologies Corporation (d/b/a Wabtec Corporation) filed a Petition for *Inter Partes* Review of U.S. Patent No. 8,714,494 (Paper 2) requesting review of eight (8) claims.
