DECISION

FURTHER ORDERED that Patent Owner must file an updated mandatory notice identifying Mr. Trac as back-up counsel in accordance with 37 C.F.R. § 42.8(b)(3);

FURTHER ORDERED that Patent Owner shall continue to have a registered practitioner represent it as lead counsel; and

FURTHER ORDERED that Mr. Trac is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Part 42 of Title 37, Code of Federal Regulations, and shall be subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. § 11.101 *et seq*.
