request termination of this *inter partes* review of U.S. Patent No. 6,975,719.

Termination of this review is appropriate because the parties have resolved their dispute regarding U.S. Patent No. 6,975,719 and have reached an agreement to, among other things, terminate this review.<sup>1</sup> Ex. 2001 (submitted as business confidential information pursuant to 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74(c)). "Generally, the Board expects that a proceeding will terminate after the filing of a settlement agreement." *Oracle Corp. v. Cmty. United IP, LLC*, CBM2013-00015, Paper 13 (July 25, 2013) (citing Office Patent Trial Practice Guide, 77 Fed. Reg. 48756, 48765–66 (Aug. 14, 2012)).

A petition for review was filed on January 6, 2017. *Inter partes* review was instituted on July 12, 2017. A patent owner's response has not yet been filed.

The agreement filed herewith as Ex. 2001 resolves the parties' disputes only with respect to U.S. Patent Nos. 6,975,719 and 7,245,715. The parties have not resolved any disputes related to other IPR proceedings (*i.e.*, IPR2017-00609, IPR2017-00610 and IPR2017-00616).

The parties desire that the agreement be maintained as business confidential information under 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74(c), and a separate joint request for such is being filed contemporaneously.
