Pursuant to 35 U.S.C. § 317(a), 37 C.F.R. §§ 42.72 and 42.74, and the Board's authorization of December 18, 2017 (*see* Exhibit 2016), Petitioner CPI Card Group Inc. ("CPI") and Patent Owner Gemalto S.A. ("Gemalto") (collectively, the "Parties") jointly move the Board to terminate IPR2017-01320.

The Parties do not contemplate any litigation or proceeding involving the subject patent in the foreseeable future.
