2	JUDGE ANKENBRAND: Good morning, everyone. Today is
3	our final hearing in IPR2017-10526 and IPR2017-01528 between
4	petitioner Mylan Pharmaceuticals Inc. and patent owner
5	Sanofi-Aventis Deutschland GmbH.
6	I'm Judge Ankenbrand. I'm joined today by Judge
7	Franklin on my right and Judge Pollock on my left.
8	Counsel, can you please introduce yourselves and let
9	us know who will be making the argument today? We'll start
10	with petitioner Mylan.
11	MR. CARSTEN: Good morning. My name is Doug Carsten
12	from Wilson Sonsini, and I'll be presenting the argument.
13	Also with me is lead counsel Jeff Guise, Rick
14	Torczon, and Ellie Steiner. And we also have representatives
15	from Mylan Pharmaceuticals Inc. here, Tom Jenkins and Matt
16	(indiscernable)

18	JUDGE ANKENBRAND: Thank you, Mr. Carsten, and good
19	morning.
20	And how about for patent owner? Who do we have
21	today?
22	MR. DESAI: Good morning, Your Honors. Anish Desai
23	here for patent owner. And with me is also lead counsel
24	Elizabeth Weiswasser, and patent counsel Andrew Iskin (phonetic).
25	JUDGE ANKENBRAND: Okay.



1	MR. DESAI: We also have a client representative
2	here, Stephanie Donahue.
3	JUDGE ANKENBRAND: Good morning to you.
4	Welcome, everyone. It's good to have you here
5	today. We appreciate everyone making the effort to be here
6	for the hearing, especially those coming from the West Coast.
7	It's quite early.
8	We set forth a procedure for today's hearing in our
9	trial order. Just to remind everyone, each party's going to
10	have 60 minutes of total time to present arguments.
11	Petitioner has the burden of showing unpatentability
12	and petitioner will go first, and then after that, Mr. Desai
13	will proceed for patent owner.
14	Mr. Carsten, would you like to reserve any time for
15	rebuttal?
16	MR. CARSTEN: Yes, Judge Ankenbrand. I'd like to
17	reserve 20 minutes for rebuttal.
18	JUDGE ANKENBRAND: Okay. During your presentations
19	please remember to identify any demonstrative exhibits by
20	reference or that you reference by either slide or screen
21	number. This will help ensure the clarity and accuracy of
22	our transcript.
23	One reminder. Objections should be made during your
24	own argument time, not during opposing counsel's argument
25	time, with one caveat: If anyone begins to discuss



1	information that is covered by the motions to seal and
2	proposed protective order, any counsel can stand up and alert
3	us to that, and we'll have to have a conversation about
4	whether we need to continue down that road or whether we need
5	to send some people out of the room that are not privy to
6	that information. But we can cross that bridge if we come to
7	it.
8	I'll try to give each counsel a warning when you're
9	reaching the end of your argument time. Sometimes I forget
10	to do that. But the numbers will be on the screen behind
11	me, and there's also some lights that will tell you when
12	you're entering getting close to the end, and then when
13	you should finish your argument.
14	The last thing I want to remind the parties is that
15	the hearing is open to the public, and a full transcript of
16	the hearing will be made part of the record.
17	I think with that, we're ready to begin. So I'll
18	just set the clock, and then you can start.
19	I'll start the clock whenever you're ready.
20	MR. CARSTEN: I'm ready. Thank you.
21	Good morning, and may it please the Board. My name
22	is Doug Carsten, and I'm presenting on behalf of Mylan
23	Pharmaceuticals Inc., the petitioner in two IPRs, these IPRs
24	relating to two patents that block legitimate market
25	competition and allows Sanofi to reap billions out of U.S.
