2	JUDGE GIANNETTI: So good afternoon, everyone.
3	This is the final hearing in IPR2017-01607, Hutchinson
4	Technology versus Nitto Denko Corporation involving patent
5	8,692,126. I'm Judge Giannetti. I will be presiding
6	today. Two other judges on our panel appear on the screen to
7	my left, Judge Zado and Judge Haapala appearing remotely.
8	Counsel I see counsel here, so let's start by
9	getting your appearances. Let's first start with the
10	petitioner. Who is appearing today for the petitioner?
11	MS. HAYES: Good afternoon, Your Honors. Jennifer
12	Hayes from Nixon & Peabody on behalf of petitioners, and with
13	me today are Mr. Ron Lopez and Mr. Matthew Werber also of
14	Nixon & Peabody.
15	JUDGE GIANNETTI: Welcome, back Ms. Hayes.
16	MS. HAYES: Thank you.
17	JUDGE GIANNETTI: And for the patent owner?
18	MR. CHACHKES: Good afternoon, Your Honor. Alex
19	Chachkes from Orrick, Herrington & Sutcliffe for patent owner
20	Nitto Denko, and with me today is K. Patrick Herman.
21	JUDGE GIANNETTI: Welcome back, Mr. Chachkes.
22	MR. CHACHKES: Thank you, Your Honor.
23	JUDGE GIANNETTI: So we just have one argument
24	today one case. The ground rules 60 minutes per side



- 1 starting with petitioner. The petitioner may reserve time
- 2 for rebuttal. There's a motion to amend, so I invite you to
- 3 address the motion to amend in your presentation, Mr.
- 4 Chachkes.
- 5 All right. We have your demonstratives. I
- 6 believe the remote judges have them also, but it will be
- 7 helpful and I will remind you that as you go through your

1	JUDGE GIANNETTI: That's fine.
2	MS. HAYES: We're here today to talk about the
3	'126 patent, and as set forth in the petition petitioners
4	believe that the claims of the '126 patent are anticipated by
5	or obvious over the Pan reference that is set forth in
6	grounds 1 through 4 of the petition.
7	The claims are also anticipated by or rendered
8	obvious by the Yokai reference which is grounds 5 and 6 in
9	the petition, and today we'll also be addressing patent
10	owner's contingent motion to amend which petitioners believe
11	should be denied, and I'll address those in the order set
12	forth on slide 2 of our slide deck.
13	So starting first with the Pan reference, and
14	claims 1 and 12 in particular are the independent claims that
15	are shown on slide 4 of petitioner's slide deck. Claims 1
16	and 12 are directed to a wired circuit board, and the key
17	limitations that we'll be addressing today are the metal
18	supporting layer in the wired circuit board and the reference
19	hole formed in the metal supporting layer that has a step
20	portion formed so as to surround on all sides the reference
21	hole.
22	And claims 1 and 12 are very similar. They both
23	include a limitation that the step portion can be formed in
24	the insulating layer and/or the conductive layer. Claim 1
