# **AMENDED JOINT CLAIM CONSTRUCTION STATEMENT**

Plaintiff Improved Search LLC ("Improved Search") and Defendant AOL Inc. ("AOL") submit the following Amended Joint Claim Construction Statement, updating the Joint Claim Construction Statement submitted on October 4, 2016 [D.I. 51] to reflect the terms on which the parties have reached agreement, and the terms over which there remains a dispute.

## a. The Construction of Terms on Which the Parties Agree

The parties have agreed upon the constructions of the following terms of the asserted claims:
