2	JUDGE WEATHERLY: All right. Thank you for bearing with
3	us while we get our electronic systems in order. So I've already said good
4	afternoon, I'll say it again. This is a hearing for three proceedings, IPR
5	2017-01654, IPR 2017-01890 and IPR 2017-01945 relating to U.S. patent
6	numbers 9,079,490, 9,399,327 and 9,399,326 respectively.
7	Petitioner is Donghee America Inc., and Donghee Alabama
8	LLC., and Patent Owner is Plastic Omnium Advanced Innovation and
9	Research. I'm Judge Weatherly and I'm joined to my left by Judge Kinder
10	and Judge Kaiser of our Denver Regional Office is joining us remotely.
11	Because the camera through which Judge Kaiser is viewing the proceedings
12	is located up behind my head you may want to look at that camera when
13	you're addressing him, it may make him feel a little more part of the
14	proceedings here. Please also while you're making your presentation be sure
15	to identify the slide number that you're using if there is one so that it helps
16	Judge Kaiser follow along and it also makes the transcript easier for us to
17	use after the fact.
18	Pursuant to our Hearing Order each party has 60 minutes to
19	present their argument for all three cases. They can divide it among the three
20	proceedings as they see fit. Petitioner will proceed first because you bear
21	the burden of proving unpatentability followed by the Patent Owner.
22	Petitioner you can reserve rebuttal time, Patent Owner you can reserve
23	rebuttal time also and you'll have the last word today during the proceeding.
24	Before we begin. I recognize Mr. Ricciuti on the Patent Owner's side but I

20	Honors. Those patents in those IPRs dealt with how to make the fuel tank
21	shells themselves. These IPRs, these patents, discuss how to attach
22	accessories to the fuel tank so there's a little bit of a spin on the focus of
23	these patents.

25	riveting is and here I'm looking at slide 6, the 490 patent gives a description
