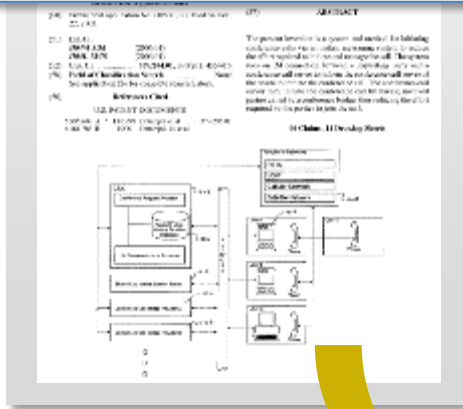

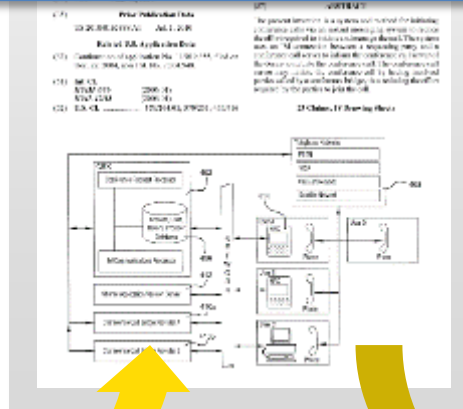

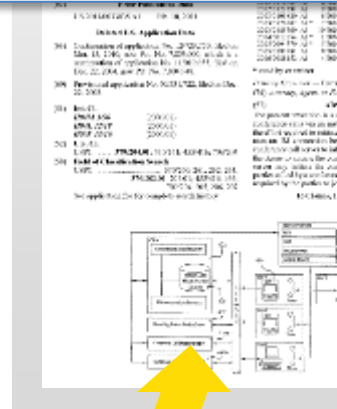

 - Claims 1-4, 6-8, 18, 21, and 22 are obvious over *Tanigawa* and *Liversidge*
- '194 Patent:
 - Claims 1-16 are obvious over *Liversidge* and *Beyda* (US Pub 2003/0111111)

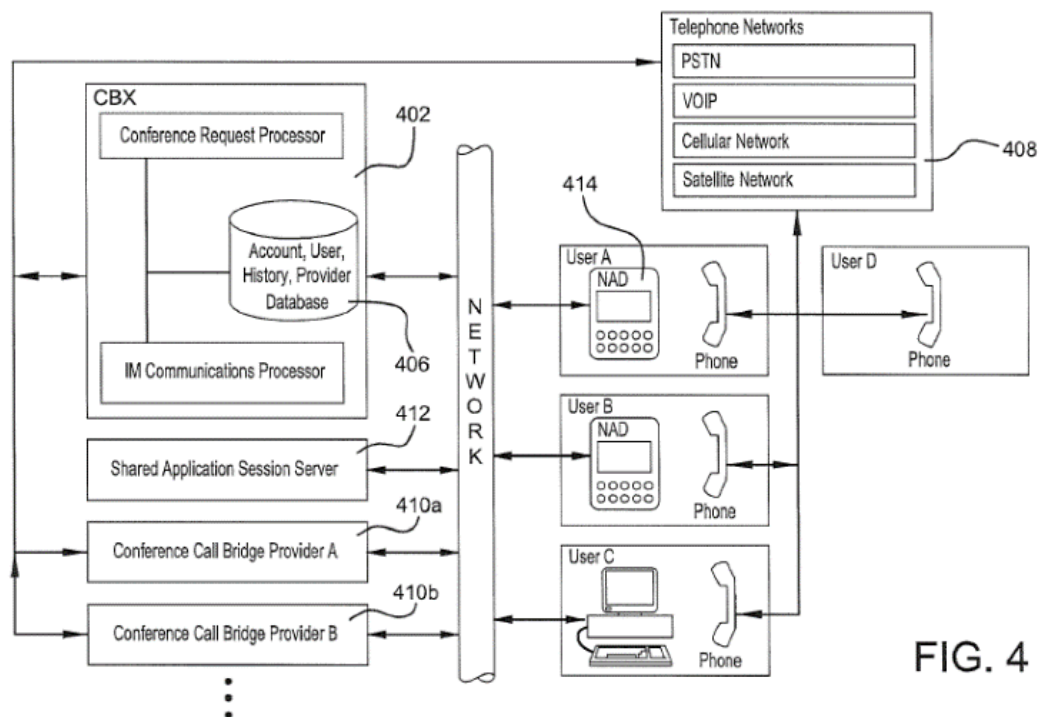
