**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES**

On August 31, 2017, FedEx Corporation (“Petitioner”) filed a Petition for *Inter Partes* Review of U.S. Patent No. 7,199,715 (“the ’715 Patent”) and paid the USPTO a total of \$23,000, which included a \$9,000 *inter partes* review request fee and a \$14,000 *inter partes* review post-institution fee for review of claims 1, 4, 5, 7, 9, 11, 14, 15, 17, 19, 22, 23, and 25 of the ’715 Patent (13 total claims).
