On August 2, 2018, Petitioner filed an "Unopposed Motion to Withdraw and Substitute Counsel" requesting that the Board withdraw Patrick McCarthy as lead counsel and requesting Jonathan Ball be designated lead counsel. Paper 20 ("Motion").<sup>1, 2</sup> Petitioner represents that "Mr. McCarthy is no longer associated with the law firm Greenberg Traurig, LLP." Motion 1. Petitioner attests that Mr. Ball is a registered practitioner. *Id.* Petitioner also indicates that Patent Owner does not oppose the Motion. *Id.* Lastly, Petitioner indicates that "new counsel for Petitioner will promptly file updated mandatory notices and a new power of attorney, reflecting the change in counsel." *Id.* 

Accordingly, it is:

RM

ORDERED that Petitioner's motion is *granted*, and Mr. McCarthy is withdrawn as counsel for Petitioner in the above-identified proceedings;

FURTHER ORDERED that Mr. Ball will be designated as lead counsel for Petitioner; and

FURTHER ORDERED that Petitioner shall file in each of the aboveidentified proceedings within 10 business days a Power of Attorney for Mr. Ball pursuant to 37 C.F.R. § 42.10, and shall file updated Mandatory Notices identifying current lead and back-up counsel in accordance with 37 C.F.R. § 42.8(b)(3).
