On March 19, 2018, we instituted trial for this proceeding. Paper 7. At this juncture of the proceeding, we do not have full briefing on the trial issues and we have not entered a final decision.

Based on the facts of this case, it is appropriate to enter judgment¹ without rendering a final written decision. *See* 35 U.S.C. § 317(a); 37 C.F.R. § 42.72.

It is

ORDERED that the parties' joint request that their agreement be treated as business confidential information, to be kept separate from the patent file is *granted*;

FURTHER ORDERED that the joint motion to terminate the proceeding is *granted*; and

FURTHER ORDERED that the proceeding is terminated.
