## **I. STATEMENT OF RELIEF REQUESTED**

Petitioner InAuth, Inc. (“Petitioner”) respectfully requests a refund of the post-institution fee it initially paid when filing its petition for *Inter Partes* Review (“IPR”) of U.S. Patent No. 9,559,852, which was assigned case number IPR2017-00150.

## **II. STATEMENT OF FACTS**
