DECISION

Granting Petitioner's Motion for *Pro Hac Vice* Admission for  
William R. Zimmerman  
*37 C.F.R. § 42.10*

Petitioner has filed an unopposed motion for *pro hac vice* admission of William R. Zimmerman in this proceeding. Paper 13. The motion is supported by a declaration of Mr. Zimmerman. Ex. 1017.

The Board has reviewed the submissions and determined that the requirements of 37 C.F.R. § 42.10 have been met and there is good cause to admit Mr. Zimmerman *pro hac vice*.

It is, therefore,

ORDERED that Petitioner's motion for admission of William R. Zimmerman *pro hac vice* is granted. Mr. Zimmerman is authorized to represent Petitioner only as back-up counsel in the instant proceeding;

FURTHER ORDERED that Petitioner is to continue to have a registered practitioner represent it as lead counsel for the instant proceeding;

FURTHER ORDERED that Mr. Zimmerman is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Part 42 of Title 37, Code of Federal Regulations; and

FURTHER ORDERED that Mr. Zimmerman is to be subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 et seq.
