**PETITIONERS' REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Petitioners Johns Manville Corporation and Johns Manville, Inc. (collectively “Petitioners”) request a refund of post-institution fees in the amount of \$31,800.00.

On March 3, 2018, Petitioners filed a Petition for *Inter Partes* review of U.S. Patent No. 9,464,207. As required by 37 C.F.R. § 42.15(a), Petitioners deposited \$54,200.00 with the U.S. Patent and Trademark Office (“USPTO”) at the time of filing the Petition to cover associated fees. Petitioners’ payment consisted of \$22,400.00 in fees associated with the request for *Inter Partes* review, and a further \$31,800.00 in post-institution fees.

On October 2, 2018, the Board issued an Order terminating the present proceeding. (Paper 8.) *Inter Partes* review was not instituted. Accordingly, Petitioners request a refund of the post-institution fees paid to the USPTO in connection with this proceeding, totaling \$31,800.00, to be paid to deposit account number 20-1430 (referencing Attorney Docket No. 084238-1081017).
