

After the signing ceremony, Longhua District, Chen Jianmin, deputy head of the District Prosecutor Attorney Yang Shimin, director of the city's Procuratorate Lirong Bin, Silver Star Group Yewei Xiong, chairman jointly inaugurated the Silver Star Technology Park Intellectual Property Attorney Office.

It is reported that the responsibilities of the IP prosecution office are mainly reflected in the following two aspects: First, in legal services, the IP prosecutorial office and the park enterprises establish a joint conference system to exchange information on the protection of intellectual property rights; prosecutors regularly visit park enterprises, Distribute menus of service companies, solicit opinions and suggestions from companies, provide menu-based legal services, and build public service platforms such as intellectual property protection WeChat and the park, and provide professional consulting services for enterprises at the first time; Special legal system propaganda, crime prevention and other activities; Second, in terms of judicial relief, the IP prosecution office shall, in accordance with the clues provided by the company, supervise IPR administrative law enforcement, civil and administrative trials, etc.; at the same time, with the park, enterprises, public security agencies, etc. The establishment of a judicial rapid relief mechanism for intellectual property rights, the implementation of a special person to deal with the criminal cases of intellectual property rights infringement and listing
