**PETITIONER'S REQUEST FOR REFUND**

On May 19, 2018, Petitioner Hyundai Motor Company (“Petitioner”) filed a Petition for *Inter Partes* review of U.S. Patent 7,143,501. Paper 2. On September 26, 2018, Petitioner and Patent Owner Michigan Motor Technologies LLC filed a joint motion to terminate the instant proceeding per a settlement agreement. Paper 5. On October 2, 2018, the Board issued a decision terminating the proceeding. Paper 7. The instant proceeding was still at a preliminary stage and the Board had not yet instituted any trial.

The *Inter Partes* Post-Institution fee of \$15,000 specified in 37 C.F.R. § 42.15(a)(2) and a Post-Institution excess claim fee for four additional claims of \$2,400 specified in 37 C.F.R. § 42.15(a)(4) were charged to Deposit Account No. 130480 with the filing of the Petition.
