PETITIONER'S REQUEST FOR REFUND OF FEES

Petitioner Interbulk USA, LLC d/b/a InterBulk Express (“Interbulk”) respectfully requests a refund of the \$18,500 post-institution fees that it previously paid. InterBulk filed a Petition for *Inter Partes* Review (IPR) of U.S. Patent No. 7,510,327 (the “327 Patent”) on June 5, 2018, and on that date paid the USPTO \$33,500.00, including:

- \$15,000 for the IPR *request fee* (fee code 1406) (37 C.F.R. §42.15(a)(1))
- \$15,500 for the *post-institution fee* covering up to 20 claims (fee code 1414) (37 C.F.R. §42.15(a)(2))
- \$3,000 for the *post-institution fee* for 5 claims in excess of 20 (\$600 x 5) (fee code 1415) (37 C.F.R. §42.15(a)(4))

On January 11, 2019, the Board issued a decision denying institution of *Inter Partes* Review. (Paper 7.)

Because this proceeding was not instituted, Interbulk is entitled to and requests a refund of the \$18,500 in post-institution fees that it paid. The refund may be deposited in Deposit Account No. 50/2762 under Order No. I2077-700050IPR.
