PETITIONER'S REQUEST FOR ORAL ARGUMENT

- Whether claims 2, 3, and 17 of U.S. Patent No. 9,535,490 are unpatentable under 35 U.S.C. § 103 as obvious over Heinrich, Balasubramanian, and Tsai.
- Reply to any arguments raised in the Patent Owner's Response and Patent Owner's Sur-Reply.
- Response to any issues specified by Patent Owner in its request for oral argument.
