Patent Owner submitted Motions for *pro hac vice* admission of Steven Lieberman (Paper 6) and Rachel M. Echols (Paper 8).<sup>2</sup> The Motions are supported by the Declarations of Mr. Lieberman (Paper 7) and Ms. Echols (Paper 9).<sup>3</sup> Petitioner has not opposed the Motions.

It is, therefore,

ORDERED that Patent Owner's Motions for admission of Steven Lieberman and Rachel M. Echols *pro hac vice* are granted;

FURTHER ORDERED that Mr. Lieberman and Ms. Echols are authorized to represent Patent Owner only as back-up counsel in the instant proceeding;

FURTHER ORDERED that Patent Owner is to continue to have a registered practitioner represent it as lead counsel for the instant proceeding;

FURTHERED ORDERED that, within seven (7) business days of the date of this Order, Patent Owner shall submit Powers of Attorney for Mr. Lieberman and Ms. Echols in accordance with 37 C.F.R. § 42.10(b);

FURTHER ORDERED that, within seven (7) business days of the date of this Order, Patent Owner shall file an updated mandatory notice identifying
