On May 28, 2020, pursuant to 37 C.F.R § 90.2(a), Patent Owner Qualcomm Incorporated ("Qualcomm" or "Patent Owner") cross-appealed to the United States Court of Appeals for the Federal Circuit the Patent Trial and Appeal Board's Final Written Decision in IPR2018-01334, entered on March 16, 2020 (Paper No. 30) and from all underlying orders, decisions, rulings and opinions that are adverse to Qualcomm.

In accordance with 37 C.F.R § 90.2(a)(3)(ii), Patent Owner further indicated that the issues on cross-appeal include, but are not limited to, constitutionality of the appointment of the Administrative Patent Judges who presided over this *inter partes* review; determination of unpatentability of claims 10, 11, 13-15, and 18-23 of U.S. Patent No. 8,838,949 under 35 U.S.C. § 103(a); any finding or determination supporting or related to those issues; as well as all other issues decided adversely to Patent Owner in any orders, decisions, rulings, and opinions.

Pursuant to 37 C.F.R. § 90.3, the Notice of Cross-Appeal was timely, having been duly filed within fourteen days after Petitioner's Notice of Appeal. Likewise, to the extent that same time period governs this Amended Notice of Cross-Appeal, it remains timely filed within that same period.

This Amended Notice of Cross-Appeal is being filed solely in view of issues encountered in filing a paper copy of the Notice of Cross-Appeal with the Director of the United States Patent and Trademark Office ("Director"). Qualcomm



attempted to file the paper copy of the Notice of Cross-Appeal with the Director by mailing it via Express Mail on May 28, 2020. On May 29, 2020, Qualcomm learned that the mailing was rejected by the U.S. Postal Service because the parcel had been inadvertently labeled with an incomplete address. Accordingly, Qualcomm is filing this Amended Notice of Cross-Appeal to reflect complete submission and delivery as required.
