PETITIONER'S REQUEST FOR REFUND OF FEES

On August 9, 2018, Microsoft Corporation filed a Petition for *Inter Partes* Review of U.S. Patent No. 6,757,718 (Paper No. 1), seeking review of claims 1-27. On January 25, 2019, Patent Owner filed an Abandonment of Contest of all challenged claims (Paper No. 6).
