DECLARATION OF PROFESSOR FRANK SHIPMAN

I, Frank Shipman, hereby declare as follows:

- 1. I am a tenured professor and associate department head of the Department of Computer Science at Texas A&M University in College Station, Texas. I have been a professor at Texas A&M since 1997, and worked at Texas A&M as a research scientist from 1995-1997. Since 2004, I have also been Associate Director of the Texas A&M Center for the Study of Digital Libraries ("CSDL").
- 2. From 1995 through roughly 2002, I worked with a team of faculty and students on the Walden's Path project at Texas A&M. This project developed a set of tools for authoring, distributing and viewing linear paths composed of annotated web pages, which we sometimes referred to as guided paths or linear paths. By 1998, we had developed several linear path authoring and viewing tools, as described in several publications, including the following:

- 3. As part of our work on Walden's Paths, we maintained a Walden's Path website (http://www.csdl.tamu.edu/walden/) at least as early as February 1996 or earlier. That website has always been, and remains, accessible to the public at the same URL. Over time it has described the Walden's Paths project, listed and provided access to our publications on Walden's Paths, and also provided access to our path authoring and path viewing software. From at least early 1996 until at least 2002, the Walden's Path website was regularly updated and accessible to the public. In addition, my Texas A&M homepage (www.csdl.tamu.edu/~shipman/) and the CSDL webpage have linked to the Walden's Path website since at least 1997. The Walden's Path webpage has also linked back to my homepage since at least 1996. In order to share our work on Walden's Paths with as many people as possible, the URL for the Walden's Path website was also included in some of our Walden's Paths publications, including:

- 4. Attached as Exhibit 1 to this declaration is a copy of an article of which I was a co-author: "Using Networked Information to Create Educational



Guided Paths," as published in Volume 3, Issue 4 of the International Journal of Educational Telecommunications ("IJET"), in 1997.

- 5. The Exhibit 1 publication, which I will refer to as "Guided Paths," was an expanded version of an earlier publication that a member of our research team presented at Ed-Telecom in 1996, titled, "Creating Educational Guided Paths over the World-Wide Web," as reflected on page 399 of Guided Paths. IJET was a quarterly journal and I would have expected Guided Paths to reach IJET subscribers in late 1997 or early 1998. In publishing this article in IJET, I expected that any member of the public could order a copy of this article beginning in late 1997 or early 1998. This is reflected in the IJET table of contents, which indicates that single issues could be ordered for \$20 plus \$2.50 shipping. As noted on page 400 of Guided Paths, Guided Paths was a DARPA-funded project approved for public release and unlimited distribution.
- 6. I have also maintained a list of my publications on my Texas A&M homepage since at least 1997, regularly updating that list to include recent publications. In at least that same timeframe, I also made a CV accessible from my website, which listed all of my publications, including the Walden's Paths publications. I began listing the IJET Guided Paths publication on my web-accessible CV at least as early as October 1997, as confirmed by the Internet Archive of my CV available at:


