**PETITIONER'S REQUEST FOR  
REFUND OF THE POST-INSTITUTION FEE**

On August 10, 2018, Microsoft Corporation (“Microsoft”) filed a Petition for *Inter Partes* Review seeking review of claims 6, 7, 11 and 12 of U.S. Patent No. 7,424,523. On October 31, 2018 the Parties filed a Joint Motion to Terminate Proceeding and Joint Request to Treat the Parties’ Agreement as Business Confidential Information (Paper No. 6). The Patent Trial and Appeal Board issued its Order Dismissing the Petition on November 6, 2018 (Paper No.7).

Petitioner challenged 4 claims, and Petitioner paid a post-institution fee calculated as follows:
