PATENT OWNER'S REQUEST FOR ORAL ARGUMENT

Pursuant to 37 C.F.R. § 42.70 and the Board's Scheduling Order (IPR2019-00706, Paper 10) dated September 4, 2019, Patent Owner BlackBerry Limited ("Patent Owner") hereby respectfully requests oral argument in this proceeding.
