



PATENT POOL MARKET ABUSE Questionable DoJ compliance and lack of transparency has created more uncertainty and fragmentation, and lowered pool benefits & adoption Scope • Essentiality often includes optional parts of spec · Unimplemented portions of spec often are included Validity • No pool checks validity even though DoJ guidelines require it • Many patents have broad claims which are easily challenged • Pricing often is based on unrealistic expectations and no presentation of the Value how financial model was created Royalty stacking, lax financial models and failure to consider aggregated SEP landscape often result in slower deployment or adoption of new technologies Proprietary and Confidential



VALIDITY - NOT CONSIDERED DESPITE DOJ GUIDELINES



"A starting point for an antitrust analysis of any patent pool is an inquiry into the validity of the patents and their relationship to each other. A licensing scheme premised on invalid or expired intellectual property rights will not withstand antitrust scrutiny" DOJ letter to MPEG-LA, 1997 (emphasis added)
