#### (57)**ABSTRACT**

A method and system for generating a program guide for a home network having at least one multi-media device connected thereto is provided. According to the method, multimedia material associated with a first home device is identified. An HTML page is generated, based on the identified multi-media material associated with the first home device. The HTML page is stored in an accessible area on the first home device. A second home device, which is browser based, may be connected to the home network to receive the HTML page and to render the HTML page, for display to a user.













