Petitioner Roku, Inc. ("Petitioner") requests a refund of the \$15,000 post-institution fee which was previously paid.

On September 13, 2019, Petitioner filed a Petition for *Inter Partes* Review (IPR2019-01608) (Paper 2) with the Patent Trial and Appeal Board of the U.S. Patent and Trademark Office.
