3 JUDGE BOUDREAU: I'm Judge Boudreau. This is the
4 hearing for cases IPR2020-00338, '339, and '486, all captioned
5 as Juniper Networks, Inc. and Palo Alto Networks, Inc. v.
6 Packet Intelligence LLC, concerning U.S. Patent Nos.
7 6,839,751 and 6,954,789.

8 I'm joined this afternoon by my colleagues, Judges
9 Hamann and Sawert.

10 Can we please have counsel introduce themselves for
11 the record, starting with Petitioner's counsel.

12 MR. RADSCH: Hi, this is Andrew Radsch for
13 Petitioner, Ropes & Gray. I'm joined in our Silicon Valley
14 office by my colleagues, Jim Batchelder and Mark Rowland, and
15 from our Washington, D.C. office, Scott McKeown. And we have
16 on the lines Palo Alto Networks' Client Representatives,
17 George Simion and (inaudible) --

18 MR. ALLGOOD: Adam Allgood, with Fisch Sigler, also
19 for Petitioner. And with me today on the phone are lead
20 counsel for these IPRs, Mr. Joe Edell, Mr. Alan Fisch, Mr.
21 Bill Sigler, Mr. Jeff Saltman, all from Fisch Sigler. And
22 then also Director of Litigation for Juniper Networks, Mr.
