



(57)	ABSTRACT	

The invention is an apparatus that facilitates access to encrypted digital media to accept verification and authentiat least one electronic identification. The at least one electronic identification could be a device serial number, a networking MAC address, or a membership ID reference from a web service. Access to the product is also managed with a plurality of secondary enablers using the at least one electronic identification reference.







