4	JUDGE TARTAL: Good afternoon, and welcome.
5	We are here for a virtual hearing by videoconference
6	in an interparty review case captioned Sony Interactive
7	Entertainment LLC, Petitioner, v. BOT M8, LLC, Patent Owner.
8	Case IPR2020-00922 concerning U.S. Patent No. 8,078,540 B2.
9	First, let me begin by introducing the panel. I am
10	joined by Judge Hagy and Judge Deshpande, and I am Judge
11	Tartal.
12	May we please have the parties' appearances? Who do
13	we have appearing on behalf of petitioner today?
14	MR. MUDD: Your Honor, Jason Mudd on behalf of
15	petitioner, and also with me is Eric Biresh.
16	JUDGE TARTAL: Good afternoon, counsel, and welcome.
17	And now for patent owner. Who do we have appearing
18	today?
19	MR. FRANKEL: Good afternoon, Your Honor.
20	Aaron Frankel from Kramer Levin, joined by my
21	colleagues Jeffrey Price and Jeffrey Eng.
22	JUDGE TARTAL: Okay. Thank you, and welcome.
23	And just to clarify, do we have the name of the
24	patent owner correct? Is it Bot M8, or do you pronounce that
25	differently?
26	MR. FRANKEL: It's pronounced Bot Mate.

1	JUDGE TARTAL: Bot Mate. Thank you.
2	MR. FRANKEL: Yes. Bot Mate.
3	JUDGE TARTAL: We set forth the procedure for
4	today's hearing in our trial order, and as a reminder, each
5	party will have 60 minutes of total time to present arguments
6	in the case.
7	Petitioner has the burden of proof and will go
8	first. Patent owner will then present opposition arguments
9	for the case. And then, to the extent petitioner has
10	reserved time, petitioner will present arguments in reply
11	for the case. Finally, if patent owner has reserved time,
12	it may present surreply arguments.
13	We will try to provide a reminder of the time
14	remaining but also ask each party to keep track of the time
15	they have available as well.
16	Counsel, are there any questions in that regard for
17	petitioner?
18	MR. MUDD: No, Your Honor.
19	JUDGE TARTAL: Or for patent owner?
20	MR. FRANKEL: No, Your Honor.
21	JUDGE TARTAL: For clarity in the transcript, when
22	you refer to an exhibit, please state for the record the
23	exhibit and page number, or for demonstratives, the slide
24	number to which you are referring.
25	When you are not speaking, we ask that you please
26	mute your connection to improve the audio quality.

9	JUDGE TARTAL: And are there any additional
10	questions from petitioner at this time?
11	MR. MUDD: No, Your Honor.
12	JUDGE TARTAL: Petitioner, how much time would you
13	tentatively like to reserve of your 60 minutes for reply?
14	MR. MUDD: 10 minutes, please.
15	JUDGE TARTAL: Okay. Then we will endeavor to give
16	you a heads up when we are approaching the 50-minute mark.
17	Petitioner, you may proceed when you are ready.
18	MR. MUDD: Thank you, Your Honor.
19	May it please the Board, Jason Mudd for petitioner,
20	Sony Interactive Entertainment.
21	Turning to Slide 2.
22	The Board has instituted these three grounds raised
23	by petitioner in this proceeding: First, in Ground 1, that
24	Claims 1 and 4 are obvious over Johnson in view of Martinek;
25	second, in Ground 2, that Claims 2 through 3 and 5 through 6
26	are obvious over Johnson in view of Martinek in further view
