**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Sony Interactive Entertainment LLC (“Petitioner”) filed a petition for *Inter Partes* Review of 1-27 claims of U.S. Patent No. 7,338,363 on May 22, 2020 (Paper No. 1). At the time of filing, Petitioners submitted a fee of \$39,800 consisting of a \$15,500.00 request fee, \$2,100 *inter partes* review for additional claim fee for seven (7) additional claims, a \$15,000.00 *inter partes* review post-institution fee, and a \$7,200.00 *inter partes* post-institution additional claim fee for twelve (12) additional claims, in accordance with 37 C.F.R. § 42.15(b). On November 20, 2020, the Board denied institution of the *inter partes* review (Paper No. 9). In view of the Board’s decision, Petitioners respectfully request a refund of \$22,200.00 for the *inter partes* review post-institution fee of \$15,000.00 and *inter partes* post-institution additional claim fee of \$7,200.00 that was submitted with their initial petition pursuant to 37 C.F.R. § 42.15(b). Petitioners request that the refund be deposited in Deposit Account No. 50-6159.
