PETITIONER'S REQUEST FOR REFUND OF IPR FEES

Petitioner Biocon Pharma Limited et al. (“Biocon”) requests a refund in the amount of \$ 15,000 to be paid to Deposit Acct. No. 501290 (Customer ID No. 27160) pursuant to the U.S. Patent and Trademark Office’s Final Rule Setting and Adjusting Patent Fees, 78 F.R. 4211, 4234-35 (Jan. 18, 2013).

On August 7, 2020, Biocon filed a Petition for *inter partes* review against U.S. Patent No. 8,101,659, proceeding IPR2020-01263. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(a), Biocon deposited an electronic payment in the amount of \$ 30,500 with the PTO at the time of filing its Petition. Biocon’s payment consisted of \$ 15,500 in fees associated with Biocon’s *inter partes* review request, and a further \$ 15,000 in Post-Institution fees.

On February 16, 2021, the Board entered a decision to terminate proceeding IPR2020-01263 denying institution. Paper 12. Accordingly, Biocon requests a refund in the amount of \$15,000 for the Post-Institution fees.
