The Court has instructed me to advise you that with regard to the March 2021 jury trial term of court, the order for trial will be as follows:

1st—Solas v. Samsung (2:19-cv-152) 2nd—Personalized Media Communications v. Apple (2:15-cv-1366) 3rd—Infernal v. Sony (2:19-cv-248) 4th—GREE v. Supercell Oy (2:19-cv-200, 237, 310, 311)

All cases are set (in the above order) for jury selection followed by trial on March 1, 2021. Should the Solas v. Samsung case, for any reason, not go forward, then the PMC v. Apple case will go forward on March 1, 2021. Should the PMC v. Apple case, for any reason, not go forward, then the Infernal v. Sony case will go forward on March 1, 2021. Should the Infernal v. Sony case, for any reason, not go forward, then the GREE v. Supercell cases will go forward on March 1, 2021.

Additionally, there will be two trial settings in the month of March 2021—March 1, 2021 and March 15, 2021.
