INTRODUCTION

On May 24, 2022, the panel conducted a telephone conference call with the parties to discuss several pending motions seeking to join these cases.²

After hearing from the parties, the Board panel expressed a desire to decide the joinder motions as soon as is reasonably possible and sought the parties' cooperation in coordinating the schedules in the cases to achieve that goal. After discussing various alternatives, the parties reached agreement with the panel on a schedule for filing replies in those cases seeking joinder. This agreement is reflected in separate orders.
