INTRODUCTION

On May 24, 2022, counsel for petitioner Code200 UAB et al.,² counsel for patent owner Bright Data Ltd., and the panel conducted a telephone conference call to discuss the pending motions for joinder with IPR2021-01492 (for IPR2022-00861) and IPR2021-01493 (for IPR2022-00862). The conference was requested by counsel for Code200. Also on the call were counsel for NetNut Ltd., the petitioner in IPR2022-01492 and IPR2022-01493, and counsel for Major Data, UAB, the petitioner in IPR2022-00915 and IPR2022-00916.³

After hearing from the parties, the Board panel expressed a desire to decide the joinder motions as soon as is reasonably possible and sought the parties' cooperation in adjusting the schedule in these cases to achieve that goal. After discussing various alternatives, the parties reached agreement with the panel on a schedule for filing Bright Data's preliminary responses to the petitions in these cases to coincide with Code200's filing of its replies to Bright Data's oppositions to Code200's joinder motions. This agreement is reflected in the order that follows.

In addition, Bright Data reached agreement with the Board panel on an extension of time to file its patent owner responses in IPR2021-01492 and IPR2021-01493. A separate order will reset the due dates for those filings.
