INTRODUCTION

On May 24, 2022, counsel for petitioner Major Data, UAB, counsel for patent owner Bright Data Ltd., and the panel conducted a telephone conference call to discuss the pending motions for joinder with IPR2022-01492 (for IPR2022-00915) and IPR2022-01493 (for IPR2022-00916). Also on the call were counsel for NetNut Ltd., the petitioner in IPR2021-01492 and IPR2021-01493, and counsel for Code200, et al., the petitioner in IPR2022-00861 and IPR2022-00862.²

After hearing from the parties, the Board panel expressed a desire to decide the joinder motions as soon as is reasonably possible and sought the parties' cooperation in adjusting the schedule in these cases to achieve that goal. After discussing various alternatives, the parties reached agreement with the panel on a schedule for filing Bright Data's preliminary responses to the petitions in these cases to coincide with Major Data's filing of its replies to Bright Data's oppositions Major Data's joinder motions. This agreement is reflected in the order that follows.

In addition, Bright Data reached agreement with the Board panel on an extension of time to file its patent owner responses in IPR2021-01492 and IPR2021-01493. A separate order will reset the due dates for those filings.
