SCHEDULING ORDER

Date	Item
August 1, 2024	Deadline to file a motion to transfer. After this deadline, movants must seek leave of Court and show good cause for the delay.
August 1, 2024	Plaintiff serves preliminary infringement contentions in the form of a chart setting forth where in the accused product(s) each element of the asserted claim(s) are found. Plaintiff shall also identify the earliest priority date (i.e., the earliest date of invention) for each asserted claim and produce: (1) all documents evidencing conception and reduction to practice for each claimed invention, and (2) a copy of the file history for each patent in suit.
September 5, 2024	Case Management Conference
September 19, 2024	The Parties shall file a motion to enter an agreed Scheduling Order. If the parties cannot agree, the parties shall submit a separate Joint Motion for entry of Scheduling Order briefly setting forth their respective positions on items where they cannot agree. Absent agreement of the parties, the Plaintiff shall be responsible for the timely submission of this and other Joint filings.
October 24, 2024	Defendant serves preliminary invalidity contentions in the form of (1) a chart setting forth where in the prior art references each element of the asserted claim(s) are found, (2) an identification of any limitations the Defendant contends are indefinite or lack written description under section 112, and (3) an identification of any claims the Defendant contends are directed to ineligible subject matter under section 101. Defendant shall also produce (1) all prior art referenced in the invalidity contentions, and (2) technical documents, including software where applicable, sufficient to show the operation of the accused product(s).

Date	Item
November 14, 2024	Parties exchange claim terms for construction.
December 5, 2024	Parties exchange proposed claim constructions.
December 12, 2024	Parties disclose extrinsic evidence. The parties shall disclose any extrinsic evidence, including the identity of any expert witness they may rely upon with respect to claim construction or indefiniteness. With respect to any expert identified, the parties shall identify the scope of the topics for the witness's expected testimony. ¹ With respect to items of extrinsic evidence, the parties shall identify each such item by production number or produce a copy of any such item if not previously produced.
December 19, 2024	Deadline to meet and confer to narrow terms in dispute and exchange revised list of terms/constructions.
January 9, 2025	Defendant files Opening claim construction brief, including any arguments that any claim terms are indefinite.
January 30, 2025	Plaintiff files Responsive claim construction brief.
February 20, 2025	Defendant files Reply claim construction brief.
February 20, 2025	Parties to jointly email the law clerks (<i>see</i> OGP at 1) to confirm their <i>Markman</i> date and to notify if any venue or jurisdictional motions remain unripe for resolution.
March 13, 2025	Plaintiff files a Sur-Reply claim construction brief.
March 20, 2025	Parties submit Joint Claim Construction Statement and email the law clerks an editable copy. <i>See</i> General Issues Note #9 regarding providing copies of the briefing to the Court and the technical advisor (if appointed).
March 24, 2025	Parties submit optional technical tutorials to the Court and technical advisor (if appointed).
April 10, 2025	<i>Markman</i> Hearing at 9:00 a.m. This date is a placeholder and the Court may adjust this date as the <i>Markman</i> hearing approaches.
April 11, 2025	Fact Discovery opens; deadline to serve Initial Disclosures per Rule 26(a).
May 22, 2025	Deadline to add parties.

¹ Any party may utilize a rebuttal expert in response to a brief where expert testimony is relied upon by the other party.

May 22, 2025	Deadline to serve Final Infringement and Invalidity Contentions. After this date, leave of Court is required for any amendment to infringement or invalidity contentions. This deadline does not relieve the parties of their obligation to seasonably amend if new information is identified after initial contentions.
July 31, 2025	Deadline to amend pleadings. A motion is not required unless the amendment adds patents or patent claims. (Note: This includes amendments in response to a 12(c) motion.)
September 25, 2025	Deadline for the first of two meet and confers to discuss significantly narrowing the number of claims asserted and prior art references at issue. Unless the parties agree to the narrowing, they are ordered to contact the Court's law clerk to arrange a teleconference with the Court to resolve the disputed issues.
November 6, 2025	Close of Fact Discovery.
November 20, 2025	Opening Expert Reports.
December 18, 2025	Rebuttal Expert Reports.
January 15, 2026	Close of Expert Discovery.
January 22, 2026	Deadline for the second of two meet and confers to discuss narrowing the number of claims asserted and prior art references at issue to triable limits. If it helps the parties determine these limits, the parties are encouraged to contact the Court's law clerk for an estimate of the amount of trial time anticipated per side. The parties shall file a Joint Report within 5 business days regarding the result of the meet and confer.
February 5, 2026	Dispositive motion deadline and <i>Daubert</i> motion deadline. See General Issues Note #9 regarding providing copies of the briefing to the Court and the technical advisor (if appointed). Deadline for parties desiring to consent to trial before the magistrate judge to submit Form AO 85, "Notice, Consent, And Reference Of A Civil Action To A Magistrate Judge," available at https://www.uscourts.gov/forms/civil-forms/notice-consent-and-reference-civil-action-magistrate-judge .
February 19, 2026	Serve Pretrial Disclosures (jury instructions, exhibits lists, witness lists, deposition designations).
March 5, 2026	Serve objections to pretrial disclosures/rebuttal disclosures.
March 19, 2026	Serve objections to rebuttal disclosures; file motions <i>in limine</i> .

March 26, 2026	<p>File Joint Pretrial Order and Pretrial Submissions (jury instructions, exhibits lists, witness lists, deposition designations); file oppositions to motions <i>in limine</i></p> <p>From this date onwards, the parties are obligated to notify the Court of any changes to the asserted patents or claims. Such notification shall be filed on the docket within seven (7) days of the change and shall include a complete listing of all asserted patents and claims. If a change to the asserted patents or claims requires leave of court (for example, if a party is moving for leave to assert additional claims), notification shall not be required until the Court grants leave, at which point the notification must be filed within seven (7) days.</p>
April 2, 2026	<p>File Notice of Request for Daily Transcript or Real Time Reporting. If a daily transcript or real time reporting of court proceedings is requested for trial, the party or parties making said request shall file a notice with the Court and email the Court Reporter, Kristie Davis at kmdaviscsr@yahoo.com</p> <p>Deadline to file replies to motions <i>in limine</i>.</p>
April 9, 2026	Deadline to meet and confer regarding remaining objections and disputes on motions <i>in limine</i> .
April 10, 2026	Parties to jointly email the Court's law clerk (<i>See</i> OGP at 1) to confirm their pretrial conference and trial dates.
April 16, 2026	File joint notice identifying remaining objections to pretrial disclosures and disputes on motions <i>in limine</i> .
April 23, 2026	Final Pretrial Conference. Held in person unless otherwise requested.
May 14, 2026	Jury Selection/Trial.
