ORDER

Granting Petitioner's Motion for

Petitioner's lead counsel, Ms. Arlene L. Chow, is a registered practitioner. Paper 6, p. 3. Petitioner shows sufficiently that Mr. Noh is an

experienced patent litigator and has an established familiarity with the subject matter at issue in this proceeding. *See* Exhibit 1 ¶¶ 2, 10 (appended to Paper 6); 37 C.F.R. § 42.10(c).

It is

ORDERED that Petitioner's unopposed motion for *pro hac vice* admission of Mr. Noh is *granted*; Mr. Noh is authorized to represent Petitioner only as back-up counsel in the instant proceeding;

FURTHER ORDERED that Petitioner is to continue to have a registered practitioner represent it as lead counsel in this proceeding;

FURTHER ORDERED that Mr. Noh is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Part 42 of Title 37, Code of Federal Regulations; and

FURTHER ORDERED that Mr. Noh is to be subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the Office's Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101–11.901.
