**WISELY PRODUCTS LLC'S AND TELEBRANDS CORP.'S  
JOINT MOTION TO TERMINATE POST GRANT REVIEW**

Pursuant to 35 U.S.C. § 327 and 37 C.F.R. § 42.74, Petitioner Wisely Products LLC, and Patent Owner Telebrands Corp., jointly request termination of the post-grant review of U.S. Patent No. 9,546,775 (“the ’775 Patent”), Case No. PGR2018-00003.

In October 2017, Petitioner filed a petition for post-grant review of the ’775 Patent.
